Course Description and Objectives:

The purpose of this class is to teach you the art of intercollegiate forensics activity, whether in a speech/individual events or debate format. According to the undergraduate catalog, this course is to cover “Training and participation in speech activities. May be repeated; maximum 4 hours. Includes Clinical Experiences: 15 hours, Type 1-4.” Please note that this course involves active participation in intercollegiate debate or speech, which requires your direct involvement in team meetings and practices to receive a passing grade, or training specific to pre-teachers headed into high school coaching positions. Importantly, though, travel to tournament competitions is *not* required to receive a grade in this course and team members do *not* have to enroll in this course. Thus, this course is designed to accomplish the following objectives:

1. To provide students with a comprehensive knowledge of forensics activities.
2. To develop students’ communication competence in forensics activities.
3. To cultivate students’ critical thinking skills.
4. To develop students’ research and information literacy skills.

In addition, this course follows the specific learning objectives relevant to debate and speech/individual events as outlined by the National Forensics Association.

Professionalism and Attendance:

Because this course is a practicum, there is no specific class meeting time as there would be in other courses. Therefore, students are responsible for arranging meetings with me and with various members of the coaching staff. Please be sure to coordinate meeting times well in advance. Also, be sure to keep appointments that you set with us as a matter of professional courtesy.

Incomplete Grade Policy:

No incomplete grades will be given. Thus, all assignments must be completed before the end of Finals Week. Take the initiative to e-mail me well in advance to determine if you have fulfilled all your assignments prior to the end of the semester (i.e., asking if there are any missing assignments during Finals Week is likely too late to do anything about it).

Course Assignments:

Within this course, two tracks are offered to students. The first track is geared toward forensics participation. The second track is geared toward forensics coaching. You should e-mail me to identify which track you wish to pursue.

Forensics Participation Track: Students must complete six presentations, through performing their forensics events in front of the coaching staff (i.e., the Director of Forensics, Assistant Director of Forensics, Assistant Director of Individual Events, Director of Debate, and/or one of the Graduate Student Coaches). Performances can be arranged with the coaching staff during their office hours or posted practice times. Prior to performing one's events, the student must research and prepare his/her events in consultation with the coaching staff. Students must also regularly attend meetings of either the Speech/Individual Events or Debate teams, under the supervision of the coaching staff.

Forensics Coaching Track: For those students involved in the Education majors who are pre-teachers headed toward a high school coaching position, this course offers an alternative set of assignments. Specifically, students may enroll in this course to learn coaching and judging pedagogy as well as team and tournament administration. These students might help run our collegiate tournaments, work as hired judges for high school tournaments, help at our high school camp, sit in on coaching sessions, and research topics or literature. Students will shadow various members of the coaching staff for each assignment (i.e., the Director of Forensics, Assistant Director of Forensics, Assistant Director of Individual Events, Director of Debate, and/or one of the Graduate Student Coaches).

Grading:

The grading scale is as follows: A= 100-90%; B= 89-80%; C= 79-70%; D= 69-60%; F= 59% and below. Percentages will be calculated based on points earned from:
